LISTING AND OFFICIAL STOCK TRADING OF AN CUONG WOOD - WORKING JOINT STOCK COMPANY (ACG)



On October 10th, 2022, Ho Chi Minh Stock Exchange (HOSE) held a ceremony to celebrate the listing decision and put **135,846,122 shares** of **An Cuong Wood - Working Joint Stock Company** (Stock code: **ACG**) into trading. The total value of **ACG** listed shares reached **VND 1,358,461,220,000**, the reference price on the first trading day was **VND 67,300/share**, the daily trading limit was +/- 20%.

An Cuong Wood - Working Joint Stock Company - ACG formerly known as **Phuong Van An Trading Co., Ltd.**, was established in 2006. The current charter capital of the Company reaches over VND 1,358 billion. The main business activities of the Company are manufacturing and distributing industrial wood, industrial wood accessories, kitchen equipment and furniture... According to the consolidated financial statements in the prospectus of the Company, in 2020 and 2021, the Company's net revenue reached nearly VND 3,753 billion and VND 3,293 billion; with profit after tax reached VND 492 billion and VND 452 billion, respectively. Particularly in the first 6 months of 2022, the Company's net revenue reached over VND 1,914 billion, equivalent to the profit after tax

is over VND 278 billion.
