Content:

On September 10, 2024, the BOD of Fortune Vietnam Joint Stock Commercial Bank issued the Board resolution to approve the following contents:

1. Approve the plan for bond public offering in 2024 as follows:

- Issuer: Fortune Vietnam Joint Stock Commercial Bank
- Bond type: non-convertible bond, without warrant, unsecured
- Par value: VND 100,000/bond
- Offering price: VND 100,000/bond
- Principal payment: on the maturity date or on the day for repurchasing before maturity
- Interest payment term: once every year
- Term: 07 years and 10 years
- Total issue value (at par value): VND 4,000,000,000,000, of which:

 - + Bond with term of 10 years: reference rate +3.2%/year
- Expected par value: 100,000,000 VND/bond
