The entire BODs of HHV for the term 2019 - 2024 has completed their term and was re-elected as members of HHV's BOD for the term 2024 - 2029 at the 2024 AGM held on May 31, 2024. On the same day, May 31, 2024, the BOD of the Company held a meeting and unanimously elected Mr. Ho Minh Hoang to hold the position of Chairman of the BOD, and elected Mr. Nguyen Tan Dong and Mr. Nguyen Huu Hung to hold the position of Vice Chairman of the BOD.

2. The meetings of the BOD:

In 2024, the BOD held 33 meetings to discuss and decide on matters within its authority. These meetings were held in accordance with the proper procedures, with complete meeting minutes and Resolutions issued in accordance with the Charter, HHV Regulations, and other relevant legal provisions; at the same time, the Resolutions of the BOD (in cases where information disclosure is required by regulations) were promptly disclosed on the same day, immediately after the end of the meeting.

3. Supervising the Board of Management by the Board of Directors

In 2024, the BOD has performed the work of governance and supervision over the Board of Management (BOM) in managing and operating the Company through the following activities:

3.1. Periodically organize working meetings with the Board of Management (BOM) (with the participation of subcommittees of the BOD and representatives of the BOS) for the BOM to report on the implementation results of production and business development plans according to the Resolutions of the General Meeting of Shareholders and the BOD of the Company. Thereby, the BOD has assessed the Company's performance in each period, oriented key tasks for the next period and proposed solutions to resolve obstacles and overcome difficulties to promptly support the BOMto effectively implement production and business activities according to the set plan. In addition, at the meetings of the BOD, the General Director (who is also a member of the BOD) is required to report and explain specifically on related issues and contents for the BOD to discuss, make assessments and have conclusions and directions for the BOD to implement.

3.2. The BOD has specifically assigned each member of the BOD to be in charge of monitoring each important area of operation of the Company; at the same time, they are

represented by the BOD to attend meetings of the BOM to discuss, debate and provide guidance to help the BOM promptly adjust appropriate plans, resolve backlogs and problems to complete the set goals.

3.3. The BOD has directed, supervised and inspected the BOM in implementing investment activities, construction and installation at projects, management and operation of traffic infrastructure works and other important production and business activities of HHV according to the targets of the Resolutions of the General Meeting of Shareholders, the BOD ensures the correct procedures, quality and progress.

3.4. The BOD has supervised and evaluated the effectiveness of the BOM's management through the strict implementation of both periodic and ad hoc reporting regime to the BOD on the Company's operations, especially reports related to the management and use of mobilized capital for HHV's development and explanations related to the Financial Statements issued during the period. After each reporting period, the BOD promptly researched , evaluated and provided timely and accurate guidance and direction to the BOM.

3.5. The BOD oversees and closely supervises financial and accounting activities, including the preparation, issuance, and auditing of Financial Statements, Annual Reports, and other important reports produced throughout the year. At the same time, the BOD discussed and requested the BOS to search for and select a qualified and reputable independent auditing firm. This selection was submitted to the AGM of Shareholders for approval to review and audit the Company's Financial Statements and other reports in accordance with regulations, reflecting HHV's actual production and business activities.

3.6. The BOD has directed and supervised the preparation and organization of the 2024 AGM of Shareholders and HHV's shareholder relations activities: participating in the assessment and approving short-term and long-term strategic plans and goals proposed by the BOD for submission to the AGM. The BOD has also periodically monitored and inspected HHV's information disclosure activities and shareholder relations work; periodically every quarter, the BOD has directed the BOM to organize conferences and meetings to provide information, exchange and frankly answer questions and concerns of shareholders and strategic investors related to HHV's operations.

3.7. The BOD has directed and supervised the organization and personnel arrangement of the BOM to continuously improve the management and operation capacity of the BOM, to maintain a dynamic, modern and scientific working environment. The BOD focused on developing high-quality, creative human resources, "dare to think - dare to do - dare to take responsibility", effectively meeting the goal of continuing to expand the scale and develop the fields of operation of HHV.

3.8. Monitor and supervise the activities of the BOM and specialized departments, divisions, and units under the Company through the activities of the Internal Audit Board, Internal Control Board, and the Person in charge of corporate governance. Thereby, the BOD has inspected and strengthened corporate governance activities, internal audit and risk control, and has promptly issued appropriate instructions and decisions to help improve the effectiveness and efficiency of management and operation of HHV.

Through supervision, the BOD assessed that the activities of the BOM in 2024 complied with the scope of duties and powers according to the Charter, the Governance Regulations, the internal regulations of the Company as well as the decentralization of management and direction of the BOD; and achieved many positive results: HHV's production and business activities in 2024 closely followed the set plan orientation, with focus, quality, and continuous maintenance; the Company's financial statements were prepared, audited, issued, and published in accordance with regulations and current accounting standards; the Company's organization, management and control system was maintained and continuously improved, operating effectively and efficiently; awareness of control, warning and risk prevention was constantly improved; shareholder relations and information disclosure were performed well according to regulations.

4. Activities of subcommittees of the BOD (if any):

The BOD has established and authorized the actions of two affiliated subcommittees, including the Internal Audit Committee and the Internal Control Committee, in accordance with the provisions of the Charter and Internal Regulations of HHV. In 2024, the subcommittees of the BOD performed well, seriously, and within the scope of assigned functions, tasks, and powers. The specific results are as follows:

4.1. Inspecting and supervising compliance with the law, the implementation of the Charter, Regulations and the implementation of the Resolutions approved by the General Meeting of Shareholders and the BOD, and decisions on management and operation of the BOM and management levels in the Company.

4.2. Supervise the production and business activities and financial situation of the Company and its affiliated units; organize the activities of specialized departments and divisions according to the model approved by the BOD and directly manage by the BOM through pre-audit, concurrent audit, post-audit and the control process "*Pre-audit - Post-audit - Re-audit*".

4.3. Participate in monitoring and examining the truthfulness of HHV's Financial statements issued in 2024 (Quarterly, semi-annual and annual Financial Statements), the Company's Capital Use Report; inspect and evaluate the compliance, accuracy and truthfulness in presenting Financial Statements, information disclosure and shareholder relations work of HHV.

4.4. Synthesize, review and provide assessment reports on compliance and effectiveness of governance and risk management; provide independent and objective advice and recommendations related to governance, risk management and internal control processes in accordance with the actual situation to achieve the Company's development goals and orientations.

In 2024, the subcommittees of the BOD performed well their assigned roles and tasks; thematic audits and controls were fully implemented, focusing on the requirements according to the set plan. Through inspection and control work, existing limitations and risks were promptly detected, thereby making timely and appropriate recommendations to ensure that the Company's risk warning and internal control systems are established and operated appropriately, in accordance with the actual conditions of the enterprise.

3. *Supervising Board of Directors, Board of Management and shareholders by Board of Supervisors :*

3.1. In 2024, based on the prescribed tasks and powers, the BOS has implemented supervision activities for the BOD and the Board of General Directors in the administration and management of the Company, specifically:
