3. The BOD' supervision of the CEO and the Board of Management (BOM):

- ✓ Participated in monthly meetings of the BOM (12 monthly meetings).
- ✓ Monitored the Bank's operations through daily, weekly, monthly, quarterly business performance reports and other reports/proposals from the BOM.
- ✓ Supervised by reviewing and processing information from the reports of the Supervisory Board and Internal Audit (IA) on the Bank's functions.
- ✓ Supervised by participating in meetings/reports of the Risk Management Committee, Human Resources Committee...

4. Activities of sub-committees under the BOD

4.1 Human Resources Committee (HRMC).

The Human Resources Committee (HRC) reviews matters related to organizational structure, nominations, compensation, and employee performance evaluations of the Bank and its subsidiaries, either through direct meetings or by receiving reports from the Human Resources Management Division and the Executive Board. Based on this information, the HRC provides assessments, analyses, and advice to the Board of Directors (BOD) to make decisions on relevant issues. Specifically, the HRC's activities in 2024 include:

- Reviewing and providing timely guidance on monthly human resource indicators and activities of the Human Resources Management Division and subsidiaries.
- Advising the BOD on decisions related to recruitment, appointments, dismissals, salary adjustments, and labor discipline actions (as per legal regulations and internal procedures) for individuals within the BOD's approval authority.
- Reviewing and assessing the standards and conditions for electing and appointing new members to the Board of Directors in 2024.
- Advising the BOD on regular activities such as: evaluating the work performance of 2023, formulating the 2023 work performance bonus plan, approving the 2024 headcount and personnel costs, setting KPIs for 2024 for VPBank leaders and subsidiary executives. Additionally, the HRC

advises the BOD on action plans and key activities for the entire system in the field of human resources management at VPBank in 2024.

- Directly evaluating the 2024 annual salary review plans, updating employee segment positioning at VPBank as a basis for developing effective policies and schemes.
- Evaluating and approving the Young Talents project.
- Evaluating and updating the list of individuals eligible for the VPHome special benefits program to ensure retention of key employees of the Bank.
- Assisting subsidiaries in developing and standardizing human resources governance regulations; advising subsidiaries on recruitment and appointments of key leadership personnel.
- Advising the BOD on issuing operational regulations and amendments for the FDI Center, the Communications and Marketing Center, the Financial Markets and Transaction Banking Division, the Governance and Data Analytics Division, as well as updating the organizational structure for the SME Banking Division, the Legal & Compliance Division, and the Debt Recovery & Management Division.

4.2 Risk Management Committee

VPBank's Risk Management Committee (RMC) always proactively provides timely directions to enhance the Bank's risk management capacity and adaptability. As a result, the Bank has maintained stable asset quality and established a solid foundation for business growth activities. Specifically, in 2024, the RMC has implemented the following activities:

- Closely monitoring and maintaining VPBank's risk profile within safe thresholds through the Risk Appetite Statement for 2024-2026 and the 2024 top-down Strategic Risk Management Indicators. Under the guidance of the RMC, these indicators have been continuously reviewed throughout the year and adjusted promptly to reflect significant changes in the risk profile while aligning with the Bank's business direction, and ensuring compliance with the State Bank of Vietnam (SBV) and investor requirements.
- Continuing the implementation of a risk management framework (RMF) in compliance with SBV regulations, with the aim of upgrading to advanced international standards. In 2024, the Bank continues to comprehensively improve its processes, regulations, models, and IT systems to meet Basel III standards. Additionally, the Bank consistently fine-tunes and upgrades these elements in line with the SBV's guidance, aiming to be one of the leading banks in piloting Basel III comprehensively in 2025.
- Closely monitoring the results of Capital Adequacy (ICAAP) and Liquidity (ILAAP) stress tests, conducted biannually based on the updated business plan for each phase of 2024. Adverse scenarios are thoroughly reviewed, taking into account global macroeconomic fluctuations. This allows the Bank to accurately estimate the impacts on capital and liquidity while having contingency plans ready for all scenarios.
- Proactively monitoring the implementation of the Continuous Business Management Strategy across the entire bank and providing timely advice to the Board of Directors to maintain stable operations and ensure business development goals are met at all times.
- Supporting the transition towards a green economy in Vietnam, in line with the government's vision for 2050, by developing a plan aimed at achieving net-zero emissions with specific actions

and timelines. In 2024, to integrate ESG risk management into the Bank's overall RMF, the RMC has advised on monitoring a new strategic RMF indicator related to credit exposure to the coal-fired power sector, gradually reducing exposure to carbon-intensive industries, and promoting sustainable growth.

- Focusing on enhancing information security risk management amidst increasing complex challenges and continuous innovation demands both domestically and internationally. The RMC is committed to building an information security management system that meets advanced international standards (ISO 27001, PCI-DSS). At the same time, the RMC has provided timely directions to upgrade the information security system to comply with new regulations set by the governing authorities, such as personal data protection and building a centralized biometric database, ensuring no disruption to the Bank's business development.
- Advising the Board of Directors on the approval and issuance of i) Capital Costs for 2025, ii) Risk Appetite Statement for 2025-2027, and iii) the list of Key Activities & Key Risks, etc., to ensure alignment between risk appetite and annual goals, as well as effective implementation of the Bank's overall business strategy and compliance with SBV requirements.

In 2024, the SB held 11 meetings to implement tasks according to its function and responsibilities. At these meetings, the SB discussed the execution of the quarterly key tasks and gave relevant instructions to Internal Audit (IA), particularly:

- January 2, 2024: SB meeting to approve the assignment of tasks to SB members;
- January 16, 2024: First Quarter 2024 Meeting: (i) Summary of Supervisory Board activities in 2023; (ii) Key tasks in 2024; (iii) SB plan for the first quarter of 2024;
- March 29, 2024: SB meeting to approve the results of the appraisal of VPBank's Financial Statements 2023;
- April 1, 2024: Q2 2024 Meeting: (i) Summary of SB activities in Q1 2024; (ii) Key tasks in Q2 2024; (iii) Approval of SB's draft documents and reports;
- May 6, 2024: SB meeting approved the issuance of regulation on organization and operation of the Board of Supervisors after consulting at the Annual General Meeting;

3. Supervisory Activities of the Supervisory Board (SB) over the Board of Directors (BOD), Board of Management (BOM), and Shareholders:

The supervisory activities of the SB focus on matters related to its responsibilities as stipulated by law, the Charter, and the Organizational Structure and Operating Regulations of the SB, including: i) The management governance of VPBank; (ii) The implementation by the BOD and BOM of the orientations, goals, and business targets approved by the Annual General Meeting (AGM); (iii) Other matters as prescribed by law.

Through the results of the supervision and internal audit (IA), it is shown that, in essence, the Bank has:

- Established an Internal Control System (ICS) comprising three independent defense lines that basically meet the requirements of Circular 13/2018/TT-NHNN dated May 18, 2018, which provides regulations on the internal control system of commercial banks and foreign bank branches, including: (i) Ensuring there are mechanisms for delegation, empowerment, organizational structure, operational mechanisms, regulations, and processes; (ii) Establishing functions for risk identification and control within business units and direct support units; (iii) Developing internal policies/regulations for risk management (RM), risk measurement, monitoring, and legal compliance; (iv) Setting up certain cross-checking units in high-risk business areas or where support systems exist.
- The system of documents, regulations, and processes for ICS and RM basically meets legal requirements, with key control points designed.
- In the operation of units, basic compliance with the Bank's internal regulations is ensured. Through the results of supervision at various levels and IA results, the SB has promptly made recommendations to the BOD and BOM regarding measures to strengthen controls, improve internal regulations, and enhance compliance culture in certain units... to minimize and reduce risks, ensure legal compliance, and improve operational quality and effectiveness.

4. The SB's cooperation with the BOD, BOM and other managers:

The BOD, BOM and SB cooperated in the monitoring, audit, and supervision to ensure that the SB carried out and fulfilled its tasks according to the law, charter and regulation on organization and operations of the SB. The opinions and recommendations given by the SB/IA were also acknowledged and the relevant remedies were taken by the BOM.

During the year, the Supervisory Board (SB) participated in several meetings of the Board of Directors (BOD), committees, and councils to promptly update information for supervisory purposes and coordinate with the BOD and Board of Management (BOM) in directing/implementing the requirements of state management authorities, supervising, monitoring, and addressing issues based on the conclusions of inspection and supervisory authorities, if any.

5. Other Activities of the SB:

- Supervisory Oversight of IA Management through:
 - The SB provides guidance and directs IA to implement the annual audit plan;
 - Directing IA to update risks and implement according to new legal regulations and directives from the State Bank of Vietnam (SBV) directly related to the SB and IA, so as to adjust the audit approach in line with the bank's actual developments and the new requirements of the law and regulatory authorities;
 - Directing IA to monitor and urge the BOM to implement corrective actions for audit recommendations to ensure they are appropriate and completed on time.
- Performing the review of VPBank's financial statements for the year and interim period in accordance with legal regulations and VPBank's internal regulations;
- Fulfillment of regular and ad hoc reporting requirements from the SBV;

- Guiding and directing IA to enhance the quality of IA personnel through training activities to meet audit requirements. Developing solutions to retain key IA staff through career development, professional training, soft skills, and implementing the bank's general training policies.

Based on criteria assessing compliance with current corporate governance regulations and the application of best practices in corporate governance, including new points related to the implementation of sustainable development at the company, VPBank surpassed over 500 listed companies on the HNX and HOSE stock exchanges to make it to the final round and was recognized by the organizers as one of the top 10.
- VPBank continued to rank in the Top 20 companies with the highest ESG (Environmental, Social, and Governance) scores in the VNSI (VN Sustainability Index) for six consecutive years and in the top 5 largest market capitalization stocks in the VNSI in 2024.
- VPBank was also listed as one of the top 50 pioneering companies practicing the best corporate governance and committed to improving the quality and corporate governance ratings for Vietnam.
