## 3. Supervisory Activities of the Board of Directors over the Board of Management:

In 2024, the production and business of the Company has encountered difficulties due to the following key reasons:

**Global Steel Market:** Geopolitical conflicts in various regions worldwide remained intense, disrupting exports and the circulation of goods. Steel prices from China and Southeast Asia have been declining, creating competitive strain on domestic products.

**Domestic Market:** The domestic market was subdued due to very weak demand. The significant increase in steel imported from China to Vietnam brought about challenges for the domestic market. The intense price competition continued to be a critical issue for the Company due to the downward trend of finished steel prices. Competitors with strong financial resources pursued market dominance by introducing cheaper products, purchasing scrap materials at high prices,...

Despite these difficulties, the Board of Directors has well supervised the activities of the Board of Management to ensure the Company operated in line with the objectives and

expectations of shareholders. The Board of Directors consistently provided timely guidance and support, allowing the Board of Management to respond flexibly to market fluctuations.

In 2024, the Board of Directors has implemented the resolutions of the 2024 Annual General Meeting of Shareholders, fully adhering to the authority and responsibilities outlined in the Company's Charter and the Law on Enterprises.
