The State Securities Commission (SSC) has received Notification Dossier No. 115/2026/TB-MHC dated September 8, 2026, regarding the maximum foreign ownership ratio of MHC Joint Stock Company (the Company) at **0%**. The SSC hereby provides the following opinions:

1. Organizations and individuals participating in the preparation of the dossier shall be legally responsible for the legality, accuracy, truthfulness, and completeness of the dossier pursuant to Clause 1, Article 11a of Securities Law No. 54/2019/QH14, as amended and supplemented by Law No. 56/2024/QH15, and shall be responsible for the review results of the maximum foreign ownership ratio at the Company in accordance with applicable laws.

In the event that the Company's current foreign ownership ratio exceeds the legally permitted foreign ownership limit, the Company must comply with Clause 5, Article 139 of Decree No. 155/2020/ND-CP detailing the implementation of a number of articles of the Securities Law, as amended and supplemented by Decree No. 245/2025/ND-CP.

2. The SSC requests the Company to fulfill its information disclosure obligations under Clause 2, Article 13 of Circular No. 96/2020/TT-BTC guiding information disclosure on the securities market, as amended and supplemented by Circular No. 68/2024/TT-BTC and Circular No. 18/2025/TT-BTC, and to strictly comply with regulations governing foreign ownership ratios in the Vietnamese stock market.

3. The Vietnam Securities Depository and Clearing Corporation shall perform system updates and adjustments regarding the maximum foreign ownership ratio of the Company in accordance with Clause 4, Article 142 of Decree No. 155/2020/ND-CP, as amended and supplemented by Decree No. 245/2025/ND-CP.

The SSC hereby informs the Company, the Vietnam Securities Depository and Clearing Corporation, and relevant entities for awareness and compliance./.
