- The company has successfully offered 3,445,977 shares to the public for existing shareholders for raising the fund to invest Giao Long Paper Factory, Phase 2. On February 22, 2019, Ho Chi Minh City Stock Exchange was issued the Decision No.46/ QD-SGDHCM on the approval for the Company to issue more 3,445,977 shares. The Company has registered for the trading of these additional shares from the date of March 05, 2019 and on January 17, 2020.
- The company issued shares to pay dividend 2018. On August 19, 2019, Ho Chi Minh City Stock Exchange was issued the Decision No. 323/QD-SGDHCM on the approval for the Company to issue more 8,959,257 shares. The Company has registered for the trading of these additional shares from the date of August 28, 2019.
- Vietnam Securities Depository - Ho Chi Minh City Branch has issued Letter No 6493/CNVSD-DK dated 04/11/2019 on the transfer of 1.200.000 shares from conditional transferable shares to free transferable share .
- Dong Hai has issued 2.239.000 shares under the selection program for employees to supplement working capital. On January 3, 2020, the State Securities Commission issued official letter No. 30/UBCK-QLCB on reporting the results of ESOP issuance. Dong Hai is carrying out the procedures for additional stock registration and listing as regulations.
