### HOCHIMINH STOCK EXCHANGE WELCOMES THE FIRST TRADING DAY OF LIEN VIET POST JOINT STOCK COMMERCIAL BANK



On 9<sup>th</sup> November 2020, Hochiminh Stock Exchange (HOSE) organised a ceremony to celebrate the listing of Lien Viet Post Joint Stock Commercial Bank (Stock Code: LPB). There were 976,948,319 shares listed on the exchange worth more than VND 9,769 billion. The reference price on the first trading day was VND 11,800 per share with a price range of +/- 20%.

Lien Viet Post Joint Stock Commercial Bank (LienVietPostBank), formerly known as Lien Viet Commercial Joint Stock Bank, was established in 2008 with the initial charter capital of VND 3,300 billion.

Throughout many years of development, its charter capital is now more than VND 9,769 billion. The core businesses of the bank are taking deposits, making loans and providing other financial services. With the aspiration to be the best bank in Vietnam, LienVietPostBank has proactively conducted researches and activities in order to provide their customers a wide range of personalised and customer-centric products/services in such a competitive environment. LienVietPostBank is the first bank to be listed in 2020, and thus, becomes the 11<sup>th</sup> bank listed on HOSE.

According to the Financial Statements in the prospectus of LienVietPostBank, in 2018 and 2019, its after-tax profit was VND 960 billion and VND 1,600 billion, respectively. Moreover, in the first six months of 2020 alone, its after-tax profit has reached VND 806 billion.
