Song Ba Joint Stock Company (Stock Code: SBA) hereby reports the profit of quarter 2/2021 and quarter 2/2020 as follows:

- Profit after CIT of quarter 2/2021: 9,628,171,234 VND.
- Profit after CIT of quarter 2/2020: 2,688,970,283 VND.

Profit after CIT of quarter 2/2021 was increased compared to the quarter 2/2020 with an amount of **6,939,200,951 VND**.

The main reason leading to an increase in business result of quarter 2/2021 compared to quarter 2/2020 was as follows:

In quarter 2/2021, the weather was favorable, Capacity of water flowing to the Hydropower reservoirs of SBA was more than that of the quarter 2/2020, so quantity electricity generation and revenue increased respectively by 19.50 % and 15.59 billion VND over the same period in 2020 (Revenue from selling electricity include Natural water resources tax, forest environment service fee and fees for granting rights to exploit water resources 6.09 billion VND)

From the above mentioned factors, profit after CIT of quarter 2/2021 has been increased **6.94** billion VND, compared to quarter 2/2020, which was equivalent to an increase rate of **258.06%**.
